




## **Revenue Growth**

- Total Revenue was Ps. 710 million in the quarter, a decrease of 4.2% compared to 4022
- Room revenue was Ps. 347 million in the quarter, a decrease of 5% compared to 4Q22
- **F&B** revenue was Ps. 290 million in the quarter, a decrease of 2% compared to 4Q22
- Other revenue was Ps. 73 million in the quarter, an 8% decrease compared to 4Q22.


### Operating Income(\$)



- During 4Q23, the Mexican peso appreciated 4.1% against the US dollar, from Ps. 17.6195 on September 30, 2023, to Ps. 16.8935 on December 31, 2023, positively impacting the Company's financial costs. The Company's short US dollar position by the end of 4Q23 was U\$\$119.4 million, equal to Ps. 2,017.0 million.
- Net Debt for 4Q23 was Ps. 2,490.6 million, which represents Net Debt/ LTM EBITDA of 3.0x.
